operating by the power of attorney, concluded a following Agreement:
1. Author, on signing the Agreement and without compensation, transfers to the Publisher the rights on publication

2. Author guarantees that:

- 2.1. the Article (including illustrations) is an original work, not published, scheduled to be published or submitted in parallel elsewhere as a whole or in part and that the Author(s) has/have full authority to confirm this.
- 2.2. if a part of the Article has previously been published, permission(s) allowing publication in the Journal has to be obtained (Copy(ies) of permission(s) should be submitted together with the manuscript).
- 2.3. he/she has the common consent of all the co-authors of the Article, rights on the publication and distribution that are to be transferred to the Publisher by the present Agreement;
- 2.4. Article contains all necessary references on cited authors and/or editions as well as references on results and facts, cited in the Article and obtained by other authors or organizations, in consent with the law currently in effect;

3. Author commits:
